CALL TO ORDER: BOARD OF HEALTH AND RIVERSTONE HEALTH CLINIC BOARD

Board Chairpersons called their respective Boards to order at 9:15 AM. John Dorr called the Board of Health to order and Acting Chairperson Tom Singer, in the absence of RiverStone Health Clinic Board Chairperson Bob Reed, called the RiverStone Health Clinic Board to order.

JOINT CEO SEARCH COMMITTEE REPORT

Co-chairs of the CEO search committee, John Dorr, Chairperson of the Board of Health, and Tom Singer, Past Chairperson of the RiverStone Health Clinic Board, provided an overview of the Joint CEO Search Committee. Co-chairperson Dorr noted that the committee was composed mostly of members from the Board of Health and RiverStone Health Clinic Board, Judy Stewart - Vice President of Organizational Innovation, serving as senior staff representative, and AMN Leadership (AMN), the retained executive search consultant.

Co-chairperson Singer reported that AMN received more than 100 applications from a diverse group of applicants across the nation, for which they screened and vetted for compatibility with the position, and finally narrowed the applicant pool to a small group of viable candidates for advancement to the next step in the process. Co-chairperson Singer added that the process, led by AMN, was very diligent and worked well. Co-chairperson Dorr acknowledged Jon Forte and Mike Follett as the two CEO candidate finalists for the RiverStone Health / RiverStone Health Clinic President & CEO position.

DISCUSSION OF CANDIDATES

John Dorr, Chairperson of the Board of Health asked for comments and questions regarding the interview process and the two CEO candidate finalists Jonathan Forte, and Mike Follett, from Board members of both the Board of Health and RiverStone Health Clinic Board.

Board members proceeded to engage in discussion and provided comments and feedback on the interview process and the CEO candidate finalists.

JOINT CEO SEARCH COMMITTEE RECOMMENDATION

Co-chairperson John Dorr, Chairperson of the Board of Health, informed Board members that the Committee worked diligently to interview the candidates, review feedback from interview groups, and discuss the two CEO candidate finalists Jonathan Forte, and Mike Follett, before making its final decision for recommendation to the Board of Health and Clinic Board for approval.

Co-chairperson Dorr announced that the Joint CEO Search Committee selected CEO candidate finalist Jonathan Forte for the RiverStone Health / RiverStone Health Clinic President & CEO position and added that the committee recommends approval from the Board of Health and RiverStone Health Clinic Board.
